1. Payment is due at signing of this agreement. **Checks are payable to Town Centre Media LLC.**
2. Town Centre Media LLC or an affiliate production company will be filming your commercial. The actual filming date will be dependent upon the Builder’s schedule.
3. You will receive a preliminary script and electronic commercial proof. A limit of two rounds of revisions can be made for the commercial. If Trade Partner fails to approve the script and/or completed commercial within two (2) weeks of receipt, BOE reserves the right to create and run the commercial As Is.
4. If Trade Partner prefers, they may submit their own commercial spot.
5. Trade Partner understands that their commercial will air as part of the **Builder of Excellence** Program as PAID PROGRAMMING in your local market. Station of airing, time slot, and frequency will be based upon revenue raised and availability.
6. Town Centre Media LLC is not accountable for delays created by the Builder or by circumstances beyond its control. If the Builder, for whatever reason, chooses not to air the program, Trade Partner understands that reimbursement will be sought from the Builder.
7. THE TELEVISION PROGRAM WILL NOT BE FILMED UNTIL THIS INVOICE IS PAID IN FULL.
8. Once signed by Client, this agreement is not subject to cancellation and is legally binding under the laws of the State of Kansas.
